Explanation:

"portable battery" means a battery that is hermetically sealed, weighs 5 kg or less, is not specifically intended for industrial use and is not an electric vehicle battery, LMT battery or SLI battery;

"industrial battery" means a battery that is specially designed for industrial use, intended for industrial use after being the subject of preparation for a change of purpose or after a change of purpose, or any other battery weighing more than 5 kg, and which is neither a battery for an electric vehicle, an LMT battery, or an SLI battery;

"light vehicle battery" or "LMT battery" is a battery that is hermetically sealed, weighs 25 kg or less, and is specifically designed to provide traction for wheeled vehicles that can be powered only by an electric motor or a combination of motor and human power, including type-approved vehicles of category L in accordance with Regulation of the European Parliament and the Council (EU) no. 168/2013 (43), and which is not a battery for an electric vehicle;

"battery for an electric vehicle" means a battery that is specifically designed to provide electrical energy for the propulsion of hybrid or electric vehicles of category L, as defined in Regulation (EU) No. 168/2013, and which has a weight of more than 25 kg, or a battery which is specifically intended to provide electricity to drive hybrid or electric vehicles of categories M, N or O, as set out in Regulation (EU) 2018/858;
